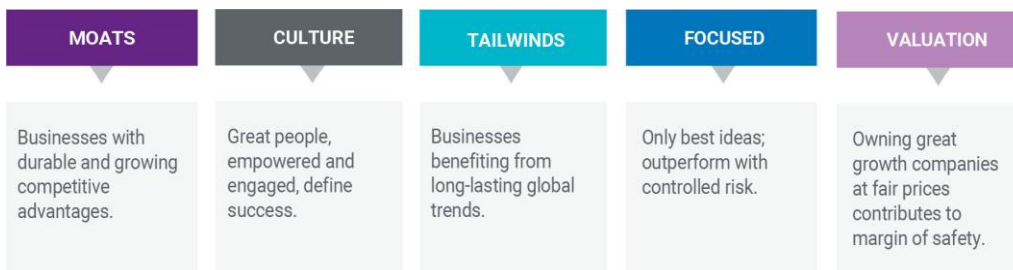

Strategy Overview – Investment Philosophy

- WCM uses a bottom-up approach that seeks to identify companies with attractive fundamentals, such a low or no debt, rising returns on invested capital, and reasonably predictable free cash flow generation. The team focuses on assessing the trajectory of a company’s competitive advantage ("economic moat") and the alignment of its corporate culture with this economic moat.
- The team's focus is on industry-leading companies led by visionary management teams with sound business strategies. These companies often dominate their industry, and the team believes they will continue that domination well into the future.
- When selecting equity investments, the minimum time horizon is 3-5 years.
- Above-average returns can only be achieved by structuring portfolios distinct from market indices. As a result, the fund typically holds 30-40 companies, concentrated around the managers' best ideas.

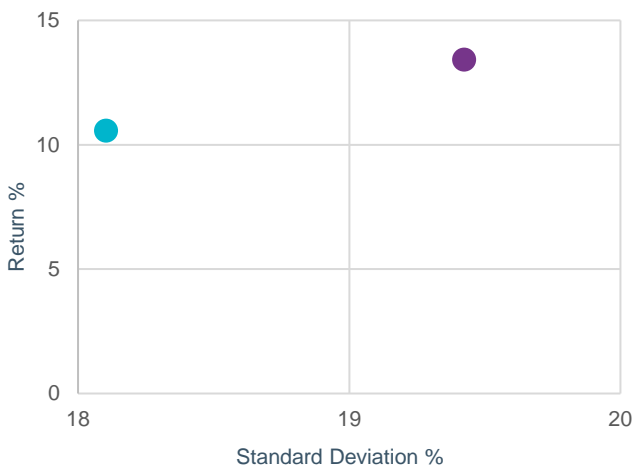

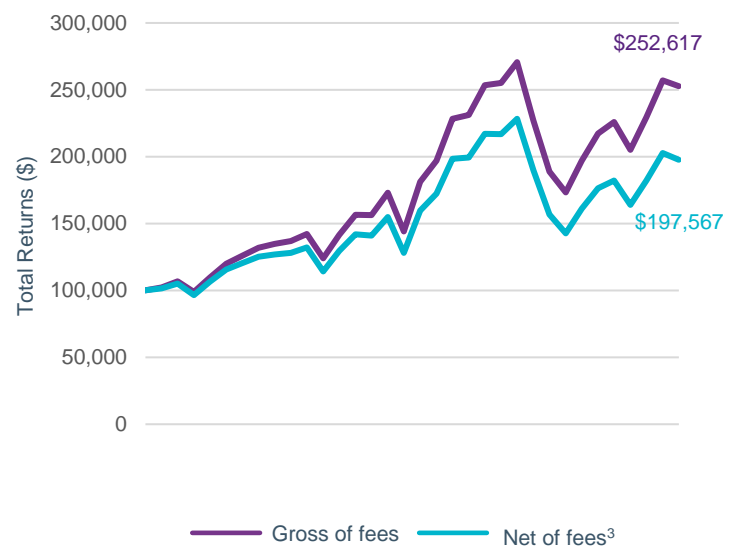

Accounts are included in the composite in the first full calendar month after management begins. Closed accounts remain in the composite through the last full month under management. The composite includes all discretionary separately managed accounts (i.e., wrap or non-commission-paying accounts) managed in the Natixis/WCM Quality Global Growth strategy and subadvised by WCM. All accounts are included regardless of size, tax status, or client-imposed restrictions. Performance is expressed in U.S. dollars. Returns are calculated on a total-return basis (appreciation and income), include cash equivalents, and are time weighted using average capital base monthly valuations. Quarterly returns are calculated by linking monthly composite returns through compound multiplication, and annual returns are calculated by linking quarterly returns.
