**1. Change of the name of SEEYOND Europe Sustainable MinVol and SEEYOND Global Sustainable MinVol (the “Sub-Funds”)**

The name of the Sub-Funds will change as follows as of 31 January 2023:

The other characteristics of the Sub-Funds remain unchanged.

**3. Change of the name of “NATIXIS LIFE” to “BPCE Life” throughout the general part of the Prospectus**
