Fund Highlights^{1,2}

- A target date fund that leverages the expertise of unique and differentiated investment managers that incorporate Environmental, Social and Governance (ESG) considerations in pursuit of better financial outcomes for investors
- The fund's glide path (asset allocation mix) is adjusted to balance the appropriate levels of risk and reward, becoming more conservative over time as the target retirement date draws closer
- The fund's allocations are carefully constructed and diversified across multiple dimensions including asset classes, investment styles within asset classes, active and passive strategies, investment managers, and approaches to incorporating ESG considerations
- In selecting managers for the funds, the team seeks managers that incorporate ESG considerations in decision-making processes as they believe considering ESG factors can aid in risk management and alpha generation



Certain ESG strategies may also seek to exclude specific types of investments. 2 Alpha refers to excess returns earned on an investment above the benchmark return.

For each fund with at least a three-year history, Morningstar calculates a Morningstar Rating™ used to rank the fund against other funds in the same category. It is calculated based on a Morningstar Risk-Adjusted Return measure that accounts for variation in a fund's monthly excess performance, without any adjustments for loads (frontend, deferred, or redemption fees), placing more emphasis on downward variations and rewarding consistent performance. Exchange-traded funds and open-ended mutual funds are considered a single population for comparative purposes. The top 10% of funds in each category receive 5 stars, the next 35% receive 3 stars, the next 22.5% receive 2 stars and the bottom 10% receive 1 star (each share class is counted as a fraction of one fund within this scale and rated separately, which may cause slight variations in the distribution percentages). Risks

The Fund's asset allocation becomes increasingly conservative as it approaches the target date and beyond. Allocations may deviate plus or minus 10% from their targeted percentages.
